LOTO-LOK steel hasps with Polypropylene injection molded grips are the preferred choice for tough working conditions and extreme environments.


LOTO-LOK Steel hasps allow upto 6 padlocks for isolating one energy source. The hasp is inserted through the isolating point and each Authorized Employee attaches their individual padlock through the lockout hasp. Lockout hasp remains immobilized until all padlocks are removed as the energy cannot be restored until the work is finished and all padlocks have been removed. This ensures worker's safety during maintenance or commissioning of plants and equipment.

MATERIAL: Constructed from C45 Grade Steel, electro galvanized with Polypropylene injection molded grips.

TEMPERATURE RANGE: -20 Deg. C to 120 Deg. C

SPECIFICATION:

- a) Scissor action with 38mm diameter jaw size.
- b) Accept locks with shackles up to 3/8" (9.5mm) diameter.
- c) Keeps equipment inoperative while repairs or adjustments are made, Control cannot be turned on until last worker's padlock is removed from the hasp.
